





Note:- While determining the permissibility of the posts as per Government Decision dated 3.11.2018, it is brought to your notice that the said permissible posts are not final as the review of the posts has not been finalised.

1. The workload of the present is calculated taking into account the number of students enrolled and the number of aided faculties/departments/subjects functioning in the college.

The work to be done has been sanctioned.

2. Enrollment in the college itself is mandatory for the faculties/units/subjects mentioned in the proposal submitted by the college for designation and the number of students certified by the university.



Mandatory number of students for grant and maximum number of students for workload calculation should be taken into consideration.

4. A bench (group) of the number of students prescribed as per government rules will be mandatory for the demonstration.

5. The hours prescribed for teaching / demonstration / tutorial, project work are prescribed by the government. Must be as per rules.

6. As per the posts sanctioned to the college, reservation points are nominated through the prescribed authority as per the prevailing reservation policy of the government

Must be certified.

7. In case of reduction in the number of students in the next academic year or reduction in the workload of the aided department due to other reasons, the sanctioned number of posts will be reduced.

8. According to the prevailing policy of the government as per the sanctioned post, recruitment should not be done without the prior permission of the government, if irregularities are found in the appointments on such sanctioned posts, the said matter will be disallowed in the determination of grant. The management and the college will be responsible for the irregular appoinAmravati.

9. The posts are sanctioned based on the grant-eligible workload of the college. For recruitment to sanctioned posts, it is necessary to independently submit a proposal and obtain a no-objection certificate as per the prevailing policy and procedure of the Government.
